If the number of businesses wanting to advertise exceeds this, they will be placed on a waiting list and priority given to those businesses for the next term. Places will be allocated as the advertisements are received, along with payment, by email ready for publication.*

Should there be spaces available for the subsequent term, then those who have previously advertised will be given the opportunity to advertise again on a first come first served basis.

*The cost of advertising **per term** will be a \$200 donation to the PTFA.*

On notification of acceptance of your advertisement, your donation will be required to be paid in full to the PTFA bank account 12-3042-0268412-00
